## **Approval of Minutes**

The minutes of the December regular board meeting were approved as submitted.

## **Treasurers Report**

Yvonne McClain provided the Treasurers Report and reported that she purchased the newest version of the Quicken (2007) software and input data. Yvonne informed the Board that a check will be cut and sent to ESI for the purchase of a computer with all education data and software in place as soon as she talks to Judy. Yvonne asked where bills and checks (APWA mail) are being mailed / delivered; with the change from ESI to Cameo Management will we be keeping the same PO Box or will we be getting a new one? Yvonne will contact Cameo in regards to where APWA mail will be sent. The Board noted that the following changes to the Treasures Report should be made:

- Move the \$2,000 cost of purchasing the ESI software and computer from 670 – Subcontractor Fees to 700 Office Supplies line item
- Move the \$4,000 in Conference Expense (500) to the 852 Conference Advance line item.

The Treasurers Report was approved as modified.

It was noted that the conference advance line item will be over budget and there was discussion relative to what conference advance monies are actually required.

### **Rob Bertini, Guest Speaker**

Rob Bertini, a professor at PSU and director of the Oregon Transportation Research and Education Consortium (OTREC) visited with the Board so share possible opportunities for APWA to become involved with the program. Rob reported that ORTEC is being funded through a Research and Innovate Technology Administration (RITA) Grant program, which is the largest grant that PSU has received \$16 million over five years. The Center is located at PSU as a four campus consortium representing OSU, PSU, OIT, U of O. The Center received approval to proceed on December 1, 2006 and they issued an RFP asking faculty and others for ideas and to submit abstracts for research and education projects; training, and outreach projects in December 2006. The first round of proposals was due today, January 12, 2007 and they received 73 abstracts for proposals relative to research and education in the transportation field. The Center is wants to access the type of training that is out there now and what type of training is needed, and they are looking for new approaches for continuing education. The theme of OTREC is Advanced Technology, Integration of Transportation and Land Use, and Healthy Communities. Currently, PSU broadcasts a transportation seminar live over the web in streaming video every Friday at noon and they can also be downloaded. These seminars have been going on since 2001 and PSU has archived these presentations for use in continuing education. Some of the funding received will be used to support these Friday seminars.

Rob asked for input from the Board. Kurt discussed the City of Eugene continuing education needs, and also the possibility of starting up student member chapters, and APWA Scholarships relative to RITA match to these dollars amounts for transportation students. Kurt suggested that Rob consider coming to the Spring conference to continue interaction and training for APWA members.

Ken Fuller asked how APWA or a jurisdiction can get a research project advocated for or into the system. Rob indicated that a new RFP will be out in March. Rob suggested that projects could be submitted, and Rob's group would help find a faculty member that would be able to champion a project. Ken noted that the City of Bend is currently

having issues with the design and implementation of round-a-bout's their impacts on EMS vehicle delay.

Yvonne McClain raised the issue of how we the Oregon Chapter can be a resource relative to getting the word out to smaller cities and counties, and if OTREC was looking for funding. Rob indicated that getting the word out about the program is the biggest need and that they are not looking for funding.

Several other questions were directed to Rob relative to project selection, cost, governmental interface, etc. Rob indicated that he would be the one to contact for further information and he will point people in the right direction.

### President's Report

- Rick Olson, Ron Polvi, and Kurt met with Dr. Edward Ray, OSU President and Rick Olson's son, who is currently the OSU Student Body President about partnering with OSU Alumni.
- Kurt distributed the 2007 Goals via email and indicated that he would like to keep "our eyes" on the 2007 Goals and for them to be a topic of discursion the next couple of months. Kurt is looking for participation from the Board to attempt to move the goals forward.
- Number one priority for the year is to up the level of activity that the Board has with the committees. The Chapter has some committees that have a great level of activity and there are some committees that have been dormant. The focus for 2007 is to try and involve more of our 700 members in APWA activities which will help us be stronger as a group.

### Chapter Conferences

General discussion centered on how we get speakers and how in the past the load has fallen to a few people. Ken Fuller volunteered to use his staff to help set up tracks and speakers. Rick will work with Ken to formalize tracks for use at conferences.

- **Fall Conference 2006, Pendleton Convention Center, October 10-13** – No formal report from Bob. Rick indicates that Bob has forwarded electronic files from the fall conference, but no financials.
- **Spring Conference 2007, Ashland; May 1-4** – Rick reports that the committee is moving forward and has a core of six people. They have had two meetings with another one scheduled next week. Concern is the conference load on staff and the possibility of being overwhelmed. Transition from ESI to Cameo could be an impact relative to the support necessary to a small organization. Rick handed out speaker forms and will be putting together a speaker's forum data base. The conference committee has selected a theme of "To Build or Not to Build, that is the question." No speakers signed up right now and Rick needs help to identify and recruit speakers. Committee has several pre-conference ideas and tours. Hugh did send out the conference information and invitation to the Northern California Chapters for this conference.

#### **Scholarship Foundation**

Dan Boss stopped by to pick up the check from the Chapter for the Scholarship Foundation. The Scholarship Foundation Board met last week. At that meeting a recommendation was made for the APWA Oregon Chapter President or a selected member of the Chapter Board to visit the college and personally hand the students their scholarship checks. Dan noted that there are no formal award functions, but at least there would be a face to face contact from an APWA Oregon Board member. The Board agreed that this is a good idea. Kurt asked if the Foundation has discussed a lower funding amount for tribute account scholarships (less than the current \$10,000 minimum). Ron Polvi and Dan Boss indicated that they have not due to the amount available for an award would be very small relative the cost of college. The Foundation needs to update their mailing address due to the transition from ESI to Cameo. The Foundation Fund is hovering at the \$200,000 level. The Board discussed the need to determine what our ultimate goal is for the Foundation. Kurt indicated that one of the chapter goals for 2007 is to determine what our goal is beyond being self sustaining.
