COREY TAPPED AS TOP 10 PUBLIC WORKS LEADER

Kurt A. Corey, P.E., director of public works for the City of Eugene, Ore., was recently named a 2006 Top Ten Public Works Leader of the Year. He was presented with the award during a celebration at the Downtown Athletic Club in Eugene on May 16.

APWA selected 10 outstanding public works professionals from across the U.S. and Canada for their professionalism, expertise and career-long dedication and service. Marking the 47th year of the award, the honor is among the most coveted and prestigious presented by the Association.

Overseeing an annual operating budget of \$58 million and a staff of approximately 415 permanent employees and 100 temporary seasonal employees, Corey has led his department to many achievements. He has also been actively involved with APWA, serving in leadership positions in APWA's Rocky Mountain and Oregon Chapters as well as serving for a number of years on the National Engineering and Technology Committee. He also spent the past 25 years officiating football and basketball at the high school and small college levels, including the Frontier Conference (NAIA) and the Northwest Football Officials Association (NIFOA) Division II and III. His basketball officiating resume includes numerous tournaments in Montana, including two state championship contests.

Klope joined the Eugene Public Works staff in 1987. Throughout his career Klope has had a strong interest in assuring that contract specifications for capital improvement projects are clear and objective and serve all parties to public improvement contracts. He helped lead an effort to develop standard specifications for state and local public works agencies. Klope also has been a leader in incorporating innovative methods and products in construction projects.

He has mentored eight college students through the Civil Engineering Cooperative Program

in collaboration with Oregon State University, and he currently serves on APWA's National Education Committee. Last fall, Klope received the William A. Bowes Service Award, the highest award given by the Oregon Chapter of APWA to honor distinguished service given to the chapter and its members.


NW PUBLIC WORKS INSTITUTE SETS TRAINING SCHEDULE



BOLI CHANGES PRINTING RULE ON WAGE RATES

On May 15, the Bureau of Labor and Industries (BOLI) initiated a rule revision that allows public agencies to include a reference to a web address for BOLI wage rates rather than include all the wage rates in paper form in their bid proposals.

According to BOLI Administrator Christine

Hammond, the rule deletes “the requirement that the applicable prevailing wage rates be physically included in all bid specifications for projects subject to the Prevailing Wage Rate law, and allow a reference to the applicable wage rates to be made in the specifications.” Although this rule is temporary, it will

become permanent through the rule-making process this fall.
